

# Domestic Abuse: A Referral Pathway for Kent and Medway

## What is domestic abuse?

Domestic abuse is any single incident, course of conduct or pattern of abusive behaviour between individuals aged 16 or over who are personally connected to each other as a result of being, or having been, intimate partners or family members, regardless of gender or sexuality. Children who see, hear or experience the effects of the abuse and are related to either of the parties are also considered victims of domestic abuse.

Behaviour is abusive if it consists of any of the following: physical or sexual abuse; violent or threatening behaviour; controlling or coercive behaviour; economic abuse; or psychological, emotional or other abuse. This includes incidences where the abusive party directs their behaviour at another person (e.g. a child). Economic abuse means any behaviour that has a substantial adverse effect on someone's ability to acquire, use or maintain money or other property, or obtain goods or services.

## What is a risk assessment (DASH)?

The DASH is a risk assessment tool used in Kent and Medway to identify the level of threat, danger and abuse that is being posed to someone. The questions may seem personal, but they help to identify how we can increase safety and support us to identify the most appropriate support services.

## Jargon Buster

<b>DASH</b>	Domestic Abuse, Stalking & Harassment and Honour Based Violence – a risk assessment checklist.
<b>Clare's Law</b>	This scheme enables the police to release information about any previous history of violence or abuse a person might have.
<b>IDVA</b>	Independent Domestic Violence Advisor – a person who works with those affected by abuse to increase their safety and wellbeing.
<b>MARAC</b>	Multi-Agency Risk Assessment Conference – a process for agencies to share information and action plan to reduce risks.
<b>MATAC</b>	Multi-Agency Task and Coordination – a meeting where high harm perpetrators are discussed and proactive plans are put in place to reduce the risk they pose.
<b>Safelives</b>	The organisation that developed and oversees DASH and MARACs.
<b>KIDAS</b>	Kent Integrated Domestic Abuse Service – are the group of organisations commissioned to provide support within safe accommodation and community-based support services for adults (16+) affected by domestic abuse in Kent.
<b>MDAS</b>	Medway Domestic Abuse Service – the service that delivers community services in Medway.
<b>ISVA</b>	Independent Sexual Violence Advisor – a person who works with those affected by abuse to increase their safety and wellbeing.
<b>SARC</b>	Sexual Assault Referral Centre – offers confidential medical and practical support to people who have recently been raped or sexually assaulted.

## What is MARAC?

MARAC is a process where agencies share relevant information about high-risk cases and make collaborative plans to help the people in that situation and reduce the risk. It identifies the actions needed to keep people safe and the most appropriate services for all those involved: the person experiencing abuse, any children connected to the people involved and the person using abusive behaviour.

If you identify someone as being high risk you should download this information and referral form and send this, together with the DASH assessment if you have one, to the email addresses enclosed.

## What is Clare's Law?

Clare's Law, also known as DVDS (Domestic Violence Disclosure Scheme), is a police-run scheme that lets you, or any member of the public, formally request or receive usually confidential information about a romantic partner's criminal history. This might be a current partner who you are worried might have been abusive in the past. It can also be an ex-partner you are no longer involved with but believe may be a threat to your safety.

## Domestic Abuse Drop Ins - One Stop Shops

### Support for people affected by domestic abuse in Kent

Kent Integrated Domestic Abuse Service (KIDAS) offers person-centred support to victims (16+) in Kent. This service includes:

- Support within safe refuge accommodation
- Specialist Independent Domestic Violence Advisors (IDVA) support
- Community Outreach Services
- Therapeutic and group programmes (e.g. Freedom or Phoenix Programme)
- Emergency welfare assistance for clients in crisis (food, energy, travel)

This service can also support access to Sanctuary provision (adaptations to make the home safer) and support for children and young people residing in safe accommodation.

### Support for people affected by domestic abuse in Medway

Medway Domestic Abuse Service (MDAS) offers specialist domestic abuse support, with a range of services to increase safety:

- Advice and information
- One-to-one specialist support to keep victims safe, to help them recover and move on, including to young people at risk
- A joined-up package of support, bringing in and working together with partner agencies in housing, health, police and services for children and others to best suit victims' needs
- Specialist group support programmes
- School programmes to help young people identify and understand abusive behaviour
- Specialist support to families affected by domestic abuse, working with the non-abusive parent and child

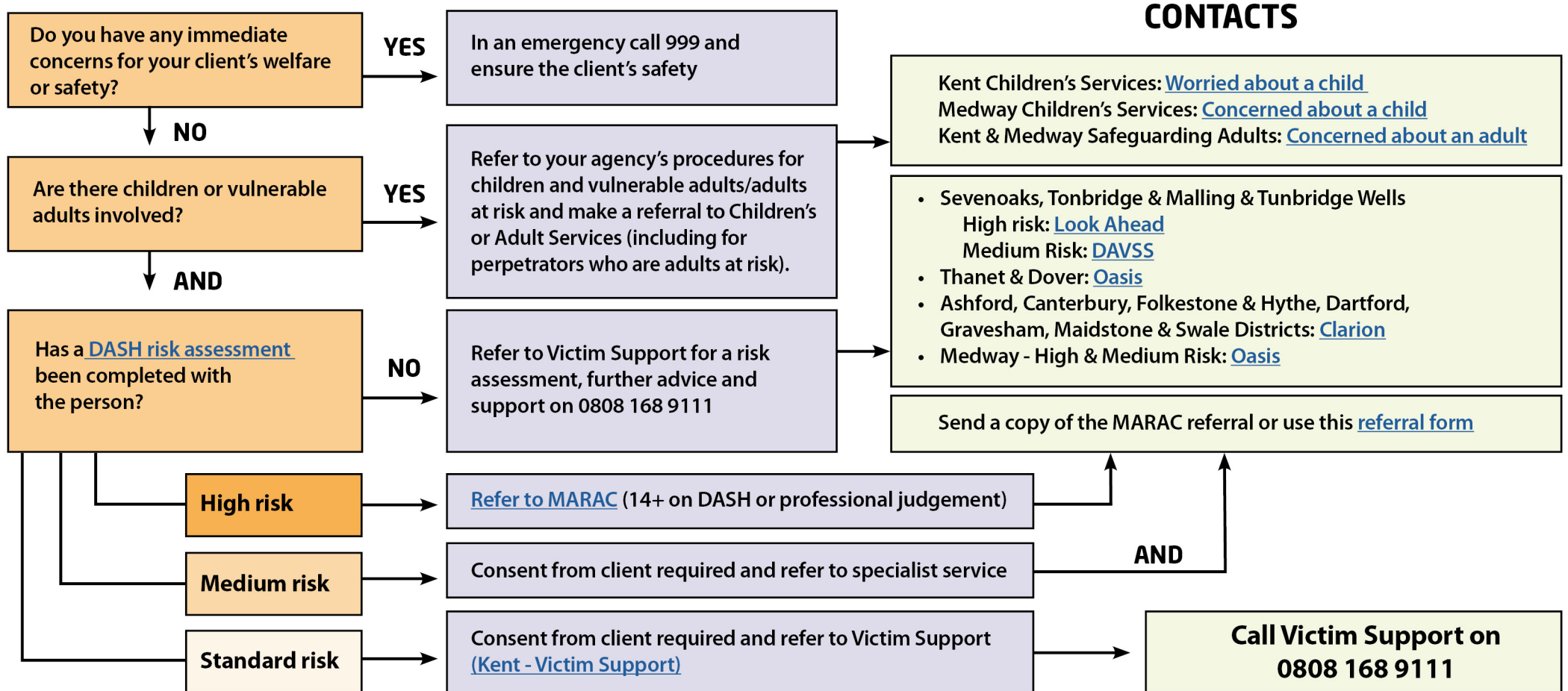
